APDA 2019 OKLAHOMA STATE PARKINSON'S EDUCATION FORUM EXHIBIT RULES AND INFORMATION JULY 27, 2019

- 1. ELIGIBLE EXHIBITS- The APDA Oklahoma Chapter Board reserves the right to determine the eligibility of any company or product for inclusion in the conference, and it reserves the right to reject, eject, or prohibit any exhibit or exhibitor.
- 2. INSTALLATION- Display/dismantling dates and hours for installation of display and dismantling will be specified at a later date. All storage and handling charges for failure to remove exhibit material from the conference facility shall be the responsibility of the exhibitor.
- 3. LIABILITY- The exhibitor agrees to make no claim, for any reason whatsoever, against American Parkinson Disease Association or the Oklahoma Chapter and sponsors for the loss, theft, damage, or destruction of goods, or for any injury to himself or employees, nor will claim be made for any damage of any nature or character, including damage by reason of failure to provide space for the exhibit, or for the removal of the exhibit, or for failure to hold the conference as scheduled.
