### WHO ARE WE?


Aging Resources is the Area Agency on Aging that serves Polk and the surrounding 7 counties. There is an Area Agency on Aging for every county in the United States.



# Future Estimates



## **IOWA RANKINGS**

In 2018, Iowa ranked 17th in the U.S. in the percentage of population age 65+.

The projected population of those 65 + in Iowa in the year 2050 is thought to be 20.3% of the states' total population.







#### **Information and Assistance**

Initial call to discuss programs or agencies that might address your concerns. This process can assist you in getting connected to available services and answer the many questions that you have about aging or living with a disability.

### **Options Counseling**

More focused than I&A, this program is a chance to look at all services to develop an individualized plan specific to your needs. Discuss possible programs and application processes.

### **Case Management**

For persons 60+ in need of help managing multiple services, Medicaid applications, and assistance establishing a long-term plan for in-depth needs. An individual is referred to this program internally and is not available to all inquiring persons.

## Program #4

## Family Caregiver Support Program

Assistance to caregivers in gaining access to supportive services

Individual counseling, organization of support groups, and caregiving training

Supplemental services, that complement the care provided by caregivers

Respite care to enable caregivers to be temporarily relieved from their caregiving responsibilities





### Who is a Caregiver?

as defined by the National Family Caregiver Support Program

- Adult family member or other informal caregiver 18 years of age and older providing care to individuals 60 years of age and older
- Adult family member or other informal caregiver 18 years of age and older providing care to individuals of any age with Alzheimer's disease and related disorders
- Older relatives (not parents) 55 years of age and older providing care to children under the age of 18 (Example is grandparents who have custody and care for grandchildren)
- Older relatives, including parents, 55 years of age and older, providing care to adults ages 18-59 with disabilities

## **FUNDING RESPITE**



- o In-home care through a home care agency of the client's choice.
- Out-of-home through an adult day care of the client's choice.
- There is also the potential for limited funding for respite through an assisted living facility or nursing home of a client's choice.




# FUNDING LIMITATIONS

- Although funding is reserved for the caregivers defined in the previous slide, we will consult with caregivers if they do not fit into any of those categories.
- Due to the large number of clients we serve, respite is limited to short-term periods of time (3-6 months). During this time, a family caregiver specialist will provide information about care options and how care may be paid for, whether that is private pay or through a Medicaid application.
- Supplemental services: One-time (rather than ongoing) assistance with deposit, rent, utility bill or durable medical equipment that is not covered by insurance can be considered.

# Adult Abuse – Iowa Definitions

Dependent Adult Abuse: Defined by any of the following as a result of the willful, negligent acts or omission of a caretaker:

- Physical Abuse
- Sexual Abuse
- Sexual Exploitation
- Financial Exploitation
- Denial of Critical Care
- Self Denial of Critical Care




#### Adult Abuse – Iowa Definitions

Vulnerable Adult: A person sixty years of age or older who is unable to protect himself or herself from elder abuse as a result of age or a mental or physical condition. Does NOT have to be dependent!

**Elder Abuse:** term used to describe general abuse regarding older adults, for those who are dependent and those who are not dependent.

Civil remedy – 235F Protection Order Must be 60 years of age or older



# What we CAN'T do...

- Provide ongoing funding
- Financially assist more than once in a 12-month span
- Provide direct services
- Get into housing on short notice
- Apply for housing



# What we CAN do!

- Provide housing lists (subsidized)
- Help to connect to resources
- Elderly Waiver applications
- Rent/utility assistance (if eligible)
- Provide options relevant to each unique situation
- Offer support and guidance
